

Part IV - Carry-forward Adjustment

The carry-forward adjustment is an after-the-fact adjustment for the difference between indirect costs recoverable using the indirect cost rate approved for use in a given year, and the actual indirect costs incurred in that year. The carry-forward adjustment eliminates the need for LEAs to file amended federal reports when their actual indirect costs vary from the estimated indirect costs on which the approved rate was based.

Where the ratio of indirect costs incurred in the current year is less than the estimated ratio of indirect costs on which the approved rate for use in the current year was based, the carry-forward adjustment is limited by using either the approved rate times current year base costs, or the highest rate actually used to recover costs from any program times current year base costs, if the highest rate used was less than the approved rate. 2019-20 Budget Assumptions

Fund 1 - Revenue

Carl Perkins

Carl Perkins allocation was budgeted for 2019-20 at \$19,125. Since developing the budget, we were awarded additional funds. To date, we have received \$29,852. Of that total, \$24,598 is unearned revenue from the 18-19 fiscal year. There was a negative balance of \$3,212. This should balance out with the revenue we received.

Resource 0000

Revenue in the amount of \$1,166,436 is included in the budget for the “Pay for Play” funding model. JPA Districts will pay \$1234 for prior year HS student enrollment (2018-19) in Center courses. We received \$2,000,000 from AB99 legislation.

SoCal ROC has projected declining amounts in revenue for 2020-21 and for 2021-22 fiscal years due to a pattern of declining enrollment from our JPA schools. We are looking for additional funding opportunities to increase our revenue. The staff is monitoring its spending carefully to avoid excessive spending. They are required to utilize program-based budgeting to ensure all expenditures are relevant to their job responsibilities and necessary for their job duties.

We are also having a financial analysis performed by School Services of California (SSC) to develop a new funding model that can sustain the school. SSC will present their findings at SoCal ROC’s February 27, 2020 Board meeting.

Adult Fees

Monies received from adults paying for fee-based classes are an additional funding source. Adult fees were budgeted at \$800,000 in the Board approved budget in June 2019. SoCal ROC has projected \$900,000 in adult fee revenue for 2020-21 and for 2020-21. We will be increasing course fees and looking to add additional courses to the schedule.

Lease payments

SoCal ROC leases property and office space. Lease payments in the amount of \$300,000 have been included in the 2019-20 budget. We are exploring creating a partnership that will allow us to increase lease revenue.

CalWorks

SoCal ROC has projected to receive approximately \$2,000 in Cal Works funding for 2019-20.

Multiyear Projections

The Multiyear Projections for 2019-20 shows revenues totaling \$4,726,276 and expenditures totaling \$5,206,071. We will be deficit spending due to not receiving any CTEIG funds. We are applying for these funds for the 2020-21 fiscal year. We are receiving \$2,000,000 in AB99 funds from the State to assist SoCal ROC in transitioning to the Local Control Funding Formula. The plan is to have the money in reserves to assist with expenses in case no further assistance will be provided by the State. AB99 has also allotted \$1,000,000 for the 2020-21 fiscal years. In 2020-21 and 2021-22 of the multi-year projections, SoCal ROC shows a budget of:

2020 – 21

Revenues: \$4,428,485
Expenditures: \$5,190,734

2021-22

Revenues: \$3,428,485
Expenditures: \$5,691,454

In order to handle the deficit spending, SoCal ROC is continuously looking to create new partnerships and add additional districts to the JPA. We expect to have possible solutions for creating sufficient revenue to sustain the school once the financial analysis is completed.

Fund 1 - Expenditures

Salaries

Salaries (both certificated and classified) have been budgeted at \$3,257,021 in the June 2019 Board approved budget. The same amount has been budgeted for 2020-21 and 2021-22.

Benefits

Benefits have been budgeted at \$606,180 in the June 2019 Board approved budget. The same amount has been budgeted for 2020-21 and 2021-22. However, it is likely that the increase in PERS and STRS will cause those costs to increase. Insurance costs are

adjusted based on information received from insurance carriers and on the amount projected for retiree benefits. This information is reviewed on an annual basis.

Supplies

Supplies have been budgeted at \$326,626 in the June 2019 Board approved budget. The same amount has been budgeted for 2020-21 and 2021-22. We are not anticipating a significant change in the amount of funds that will be spent on programs.

Other Operating Expenses

Nothing has been budgeted for this.

Fund 11 – Adult Education

This is a new fund. There is currently \$11,835 in this fund. Zero dollars have been projected for 2019-20 and 2020-21.

Fund 14 – Deferred Maintenance

The Board approved budget includes \$100,000 to spend out of Fund 14 for Deferred Maintenance in 2019-20. Zero dollars have been projected for 2020-21 and 2021-22.

Fund 20 – Special Reserve Fund for Postemployment Benefits

Nothing has been budgeted for this fund.

Fund 40 – Capital Outlay

The Board approved budget includes \$150,000 to spend out Fund 40 in 2019-20. Zero dollars have been projected for 2020-21 and 2021-22.
